#### **Amalgamation Agreement**

- Aylmer Minor Hockey, Belmont Minor Hockey and OMHA have reached a full agreement on a hybrid amalgamation
  - Representative hockey to be operated under East Elgin Minor Hockey
  - Aylmer and Belmont will continue to operate separate local league organizations
  - Belmont membership vote scheduled for Nov 17
  - Aylmer membership vote schedule for Nov 18

## Why Amalgamate

- OMHA and OHF have altered the hockey landscape to cater to higher caliber hockey
- Starting for the 2023 season Aylmer and Belmont are now surrounded by three "A" centers capable of drawing NRP's from our centers
- There are now a combined total of 9 available NRP spots open in each division (U12, U13, U14, U15, U16, U18) between these A centers (54 total)

## Why Amalgamate

- AMHA and BMHA lost a total of 30 players for the 2023/2024 season
- 2022/2023 player losses in parenthesis
- NRP loses went from 6 to 19
- Expect these numbers to increase in future years

#### Why Amalgamate

- If Belmont failed to field rep teams in U15 and U18 in 2023/2024, any players that play two years in a row in Dorchester would be able to permanently stay in Dorchester
  - It would take 2-5 years to fully recover from this affect if amalgamation was delayed
- If Aylmer did not begin the process with Belmont now, Belmont would be forced to partner with another association, possibly leaving Aylmer on the outside and on our own
- Aylmer will not be able to field competitive rep teams for very much longer on our own

#### **Amalgamation Benefits / Drawbacks**

# History

- Aylmer and Belmont have been discussing amalgamation possibilities in earnest for the past 24 months
  - Discussion revolving around the challenges of hosting competitive rep teams at certain divisions with stagnant enrollment and more kids leaving for AAA or on NRP cards
- Intent was to explore flexible options that would allow us to keep the best of what we now have in terms of the Hometown Hockey experience
  - Maintain community spirit, while cooperating at a higher level to benefit the Rep Program where both center's have future potential to struggle

# History

- Aylmer and Belmont were close to being able to hold a membership vote for amalgamation in advance of a March 2023 OMHA meeting but boundary issues delayed the vote
- OMHA approved a one-year shared boundary pilot between AMHA and BMHA to help minimize impact of the additional NRP loses
- Allowed the memberships to continue to negotiate boundaries with OMHA and allow both centers the opportunity to "trial" amalgamation before a membership vote and a long-term commitment

#### **Current State - Shared Boundary Pilot**

- Representative teams combined of Aylmer and Belmont players (62 Aylmer players and 34 Belmont players)
- Playing under the banner of East Elgin Minor Hockey Association
- New logo, colour scheme and association name selected
- Tryouts with independent evaluators
- Shared boundary committee continues to evaluate the pilot

#### Differences between Shared Pilot and Amalgamation

- Members will notice no difference
- Formal board will be created
- Separate bank account created
- Formal East Elgin Minor Hockey Non Profit Corporation to be created
- Hockey operations will run very similarly to how the current shared pilot has operated

#### **Amalgamation Administration**

- A new "East Elgin Minor Hockey Association" bylaw document has been finalized and agreed upon by the amalgamation committees
  - With OMHA for final approval
- A committee of an equal number of Aylmer and Belmont members will be setup to administer the shared boundary agreement
  - 6 Aylmer and 6 Belmont members with rotating positions
- AMHA and BMHA will continue to operate independent local league teams – NOTHING CHANGES FOR LOCAL LEAGUE

#### **Amalgamation Administration**

- AMHA and BMHA local boards will remain unchanged after amalgamation
- Representative teams will play in the Southern Counties league as dictated by the OMHA Competition Committee
- A Coach selection committee will be represented by an equal number of Aylmer and Belmont members with the committee chair holding the tiebreaker
- Tryouts will be evaluated by an independent thirdparty evaluators

#### **Boundaries**

- Amalgamated territory is very similar to existing territory
- Hard boundary established for Aylmer and Belmont
- Right of choice areas defined by new center point
  - Intersection of Lyons Line and Imperial Road
- Any player that finds themselves outside the new EEMH territory and has played for AMHA or BMHA can be grandfathered in

# **General Voting Process**

- No Proxy votes, you must be present to submit your vote
- ID required
- NRP and AAA members are eligible to vote
- OMHA has been invited to monitor the voting
  - AMHA is waiting for confirmation from OMHA if they will attend
  - There is no requirement to have a third-party witness

## **General Voting Process**

- Voting list will be compiled using data from the HCR Spordle Account.
- Please ensure your information is up-to-date and that both parents/guardians names are included.
- Step-by-step instructions on how to update this will be sent out
- Please have this completed by November 14.

# **Aylmer Voting Process**

- Aylmer vote will take place Nov 18 from 10:00am to 2:00pm at the EECC Blueline room
- Each member parent will be eligible to cast one (1) vote regardless of the number of players in the family
- For two household families the primary parents are the eligible voters
- Non-parent rostered team staff are eligible to vote
- NRPs and AAA player families are eligible to vote

## **Belmont Voting Process**

- Belmont Minor Hockey membership vote shall take place on Friday November 17 from 5pm to 9pm at Belmont Arena.
- Each parent/guardian of a member under the age of 18 is entitled a single vote each. Each parent is only entitled to a single vote regardless of how many children they have enrolled.
- Coaches, managers, trainers, board members and lifetime members also get a vote.
- NRPs and AAA families are eligible to vote
