



Aylmer Spring 3 on 3 Hockey Waiver Form

By registering with the Aylmer Minor Hockey Association (AMHA), you agree to the following conditions of registration.

I, the applicant, certify that the information provided on the online registration form to be truthful. I consent to myself or my child participating in programming provided by the AMHA. I further agree to abide by the rules, regulations, bylaws, constitution and code of ethics, and that copies of these can be provided at any time, upon request.

I, the applicant, understand that hockey is an inherently physical and demanding game with close contact with others, in which non-serious and serious injuries can occur (including damages, expenses, health complications and death). By registering in programming of the AMHA, I agree to accept the reasonable risk associated with participation in the game of hockey. I, the applicant, for himself, herself, themselves, their next of kin, executors, administrators assigned, hereby releases the AMHA, its officers, directors, administrators, coaches, assistant coaches, trainers, managers, referees, officials, servants, and agents, from all manner of claims or causes by action in any way related to personal injury or property damage by the applicant in the course of participating in, viewing or travelling to and from programming offered and sanctioned by the AMHA. I, the applicant, agree to extend this waiver to include any off-ice activities conducted by a team within the AMHA, including dry land training, team functions.

I, the applicant, agree to abide by the following conditions of membership of the AMHA.

- i.** The AMHA reserves the right to refuse any individual admission to AMHA programming.
- ii.** The AMHA adheres to the age classification system dictated by Hockey Canada and supported by the Ontario Hockey Federation (OHF) and the Ontario Minor Hockey Association (OMHA).
- iii.** New registrants must provide the AMHA with a copy of the participants' birth certificate to complete registration to confirm age.
- iv.** Participants will, at all times, on and off the ice surface, conduct themselves in a sportsman like manner, consistent with the OMHA Code of Conduct. Any instances or infractions to the Code of Conduct, is subject to review and/or investigation of the AMHA, and possible suspension from AMHA activities



- v.** All registrants must wear CSA approved helmets and masks, fastened appropriately under the chin by a strap. All registrants must also wear the necessary equipment for game play and practice, dictated by Hockey Canada, the OHF and the OMHA.
- vi.** Applicants and guardians, in order to register with the AMHA agree to complete mandatory training required by Hockey Canada, inclusive of “Rowan’s Law Education” and “Respect in Sport for Parents.” I agree that failure to complete these education modules, can result in the applicant’s removal from AMHA programming.

In signing this form, I hereby acknowledge that I have fully read this Agreement, that I understand it, and agree to it voluntarily.

I am aware that by affixing my or my dependents signature to this agreement, I am giving up my legal right to and/or remedies which may otherwise be available to me or my heirs, next of kin, executors, administrators and/or assigns, regarding any losses I may sustain as a result of my participation in AMHA programming.
